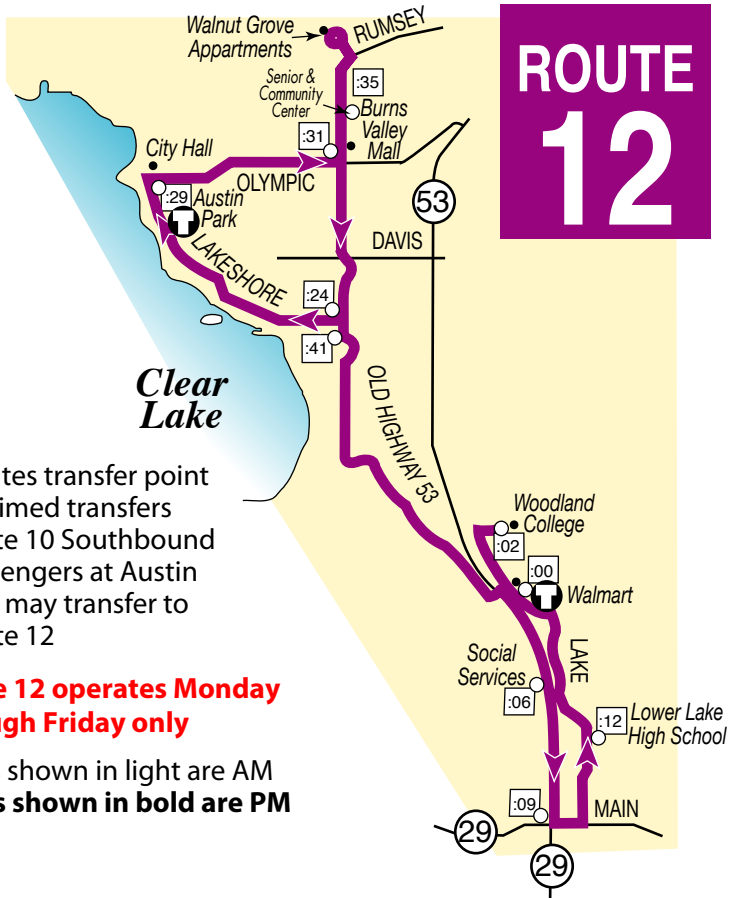
## ROUTE 12
